

**VILLAGE OF YELLOW SPRINGS
RESOLUTION 2023-28**

**AUTHORIZING THE VILLAGE MANAGER TO SUBMIT A
PURCHASE ORDER TO INSIGHT PIPE CONTRACTING, LLC,
AN H-GACBUY CONTRACTOR, FOR \$248,203.71 FOR THE
RELINING OF SELECT SANITARY SEWER LINES SITUATED
IN THE VILLAGE OF YELLOW SPRINGS**

WHEREAS, the Houston-Galveston Area Council (“H-GAC”) provides a service to local governments by securing competitively procured contracts for goods or services that local governments can then purchase through the H-GAC’s Cooperative Purchasing Program (“H-GACBuy”); and

WHEREAS, the Village’s participation in joint purchasing programs such as H-GACBuy is authorized pursuant to Ohio Revised Code Section 9.48; and

WHEREAS, by Resolution 2020-26, the Village Council authorized the Village Manager to enter into an agreement with H-GAC for the Village to participate in H-GACBuy; and

WHEREAS, it is in the best interest of the citizens of the Village of Yellow Springs that select sanitary sewer lines situated in the Village be relined; and

WHEREAS, there are no Findings for Recovery for Insight Piping, LLC on record with the Ohio Auditor of State, and

WHEREAS, the Village Manager recommends that Council authorize the Village Manager to submit a purchase order and quote to Insight Pipe Contracting, LLC, a H-GACBuy Contractor, to complete the necessary relining of select sanitary sewer lines situated in the Village at a cost not to exceed \$248,203.71.

**NOW THEREFORE, COUNCIL FOR THE VILLAGE OF YELLOW SPRINGS,
OHIO, HEREBY RESOLVES THAT:**

Section 1. Village Council hereby authorizes the Village Manager to submit a purchase order along with the quote for services to Insight Pipe Contracting, LLC, a H-GAC Contractor, to complete the necessary relining of select sanitary sewer lines situated in the Village in the amount of \$248,203.71.

Section 2. This amount will be paid from Account Number 304-1323-55103.

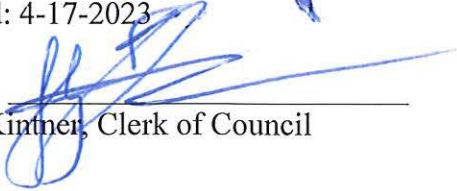
Section 3. The Village Manager is hereby authorized to issue additional Change Orders totaling no more than 10% of the bid amount, or \$24,820.30.
